10 SCHOLARSHIPS RESERVED FOR INTERNATIONAL STUDENTS ENROLLING FOR ACADEMIC YEAR 2021-22 IN A TWO YEAR MASTER DEGREE COURSE, CONDUCTED IN ENGLISH

Call for applications

The University of Camerino, in order to promote and strengthen Internationalization is awarding 10 scholarships for international students enrolling in academic year 2021/2022, in one of the 2-year Master Degree courses conducted in English.

2 scholarships will be awarded for each of the following Master Degree courses:

- **Chemistry and advanced chemical Methodologies**
- **Computer Science**
- **Geoenvironmental Resources and Risks**
- **Mathematics and Applications**
- **Physics**

The duration of the scholarships is for two academic years.

The amount of each scholarship is € 4000 per year, including fees to be paid by the awardee.

The call is open to International students resident outside Italy, citizens of the following countries:

- EU-countries (Austria, Belgium, Cyprus, Estonia, Finlandia, France, Germany, Greece, Ireland, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Portugal, Slovakia, Slovenia, Spain)
- United Kingdom
- U.S.A.
- Canada
- New Zealand
- Australia

To participate in the call, candidates

1. must have an academic qualification awarded by a foreign institution that is recognized by the Italian System of Education for access to a Master Degree course;
2. cannot be an Italian citizen;
3. cannot be legally resident in Italy.

Here, enrollment means enrollment in the first year.

All the other types of enrollment, including enrollments in years beyond the first year, transfers from other universities, or course abbreviations are excluded.

To participate in the selection, all the following requirements must be satisfied:

- 1 possession, at the latest by the time of the enrollment, of a university qualification appropriate for enrollment in the selected Master Degree course;
2. certified linguistic proficiency in English at level B2, except if English is the mother tongue;
3. not already enrolled or a graduate in any three-year degree course at the University of Camerino;
4. born on or after 1 January 1994;
5. to have obtained the most recent qualification no more than 2 years ago;
6. be resident outside Italy.



The eligibility and the relative ranking will be formulated exclusively through the evaluation procedure of the documentation presented by the candidate. Candidates are required to submit, enclosed to the application form, a scanned copy of the following documents:

- 1) copy of the passport;
- 2) official transcript of records with scores
- 3) exam syllabuses
- 3) academic qualification appropriate for enrollment in the selected Master Degree course;
- 4) Language certificate higher than B2 (except if English is the mother tongue);
- 5) curriculum vitae
- 6) letter of motivation.

The application form, available at international.unicam.it (home page), with the above documents must be submitted by e-mail to welcome@unicam.it by no later than July 30, 2021.

Applications submitted after the deadline, applications missing specified documentation or applications lacking the above requirements will not be accepted.

The Evaluation Committee appointed by the Rector, is composed of University Delegates for Internationalization and a member of the Mobility and International Relations Office.

In the selection the following criteria will be taken into account:

- Curriculum vitae and certificate of linguistic proficiency higher than B2 - max 80 points
- Motivation letter max 20 points.

In case of equal rankings, priority and preference will go to the younger of the candidates.

The Commission will formulate a merit-ranking list for each course of study. These lists will be published at international.unicam.it.

Scholarships assigned for a degree course that are not awarded will be distributed to other courses on the basis of merit and the age of the candidate.

This scholarship is not compatible with other similar scholarships awarded by e.g. Ministry of Foreign Affairs and International Cooperation (MAECI), CRUI for students with international protection, ERDIS (Regional Body for the Right to Education of the Marche Region) or UNICAM.

The ranking lists will be published by 16 August, 2021 at international.unicam.it (home page).

Successful candidates will receive notification by email. They must confirm acceptance within 5 days, or the offer is withdrawn.

Acceptance or non-acceptance must be communicated by email to welcome@unicam.it.

Enrollments to the University for academic year 2021-22 must be finalized by the deadline 17 January, 2022.

Successful candidates requiring a visa must still fill out the pre-enrollment application through the portal UNIVERSITALY.

Re-ranking in the lists will only occur in the case of a withdrawal or a non-acceptance.

The scholarship will be paid in two installments by bank transfer to a personal Italian bank account or to a prepaid Italian bank card with IBAN.

1st year € 4000

1st Instalment € 2000: January 2022 following enrollment and payment of the first instalment of the university tuition fees

2nd Instalment € 2000: May 2022 following payment of the second and third instalments of the university tuition fees

2nd year € 4000

1st Instalment € 2000: following the attainment of a minimum of 42 credits by 30 October 2022, the enrollment to the second year and payment of the first instalment of the university tuition fees

2nd Instalment € 2000: March 2023 following payment of the second and third instalments of the university tuition fees
